RE Freedom of Information - Determination

I refer to your Freedom of Information application received by the Department for Education on 10 April 2019, requesting access to:-

'Documents (including but not limited to emails, minutes, briefings, tenders, letters, notes, presentations etc) relating to enrolment modelling, future enrolment numbers or capacity management for Seaview High School.

Timeframe: 1 October 2018 to 28 February 2019'

I also refer to email correspondence dated 27 May 2019 in which you agreed to narrow the scope of the request to:-

'...final versions of minutes, briefings and relevant data.'

I also note email correspondence to this office on 28 June 2019 and telephone conversation on 23 July 2019 regarding the progress of your application.

Searches have been conducted for information in relation to your request. Fifteen documents have been located that have been identified as matching the scope of your application. I have considered the documents with reference to the *Freedom of Information Act, 1991* ("the FOI Act") and have determined to release one document in full. The remaining fourteen documents have been determined as fully exempt from release in accordance with Schedule 1, clauses 1(1)(a) and (e), as follows:-

1—Cabinet documents

- (1) A document is an exempt document—
- (a) if it is a document that has been specifically prepared for submission to Cabinet (whether or not it has been so submitted); or
 - (b) if it is a preliminary draft of a document referred to in paragraph (a); or
 - (c) if it is a document that is a copy of or part of, or contains an extract from, a document referred to in paragraph (a) or (b); or
 - (e) if it contains matter the disclosure of which would disclose information concerning any deliberation or decision of Cabinet; or
 - (f) if it is a briefing paper specifically prepared for the use of a Minister in relation to a matter submitted, or proposed to be submitted to Cabinet.


