**Audience:** This procedure applies to educators, early childhood development specialists, principals, directors and education support staff working in education and care

Status: Minor edit

# Animal care and welfare in school, preschools and early childhood services procedure

Animal care and welfare in school, preschools and early childhood services procedure (PDF 214KB)

Audience: These procedures apply to all department employees.

Status: Minor edit

#### Conflict of interest policy

**Audience:** The procedure applies to all department employees, school governing councils, school councils, preschool management committees and ministerial committees travelling overseas for business development and marketing, official business, professional development and training (excluding student excursions).

Status: Major edit

**Summary of changes:** Updated to clarify insurance requirements for department and non-department employees travelling overseas. Updated eligibility criteria for overseas student excursions. Also updated with protective security requirements of SAPSF and DPC 040 – Air travel.

### Overseas travel - student excursions procedure

Overseas travel - student excursions procedure (PDF 168KB) (staff login required)

**Audience:** The procedure applies to all employees, school governing councils or school councils, preschool management committees and ministerial committees involved with overseas student excursions.

Status: Major edit

**Summary of changes:** Updated to clarify insurance requirements for department and non-department employees travelling overseas. Updated eligibility criteria for overseas student excursions. Also updated with protective security requirements of SAPSF and DPC 040 – Air travel.

#### Overseas travel policy

**Audience:** The policy applies to all department employees, school governing councils and school councils, preschool management committees and ministerial committees. The policy applies when overseas travel is either fully or partially funded by the department.

#### Partnership governance guideline

Status: Deleted.

**Summary of changes:** Following review, the guideline is no longer required as the role/function has changed.

Audience: All department employees must participate in the performance and development process.

Status: Minor edit

Summary of changes: Updated contact information for the Performance Support team.

#### Public interest disclosure procedure

Public interest disclosure procedure (PDF 637KB)

**Audience:** This procedure is mandatory for all staff.

Status: Minor edit

Summary of changes: Updated position titles.

# Recruitment and selection of ancillary staff in schools and preschools procedure
